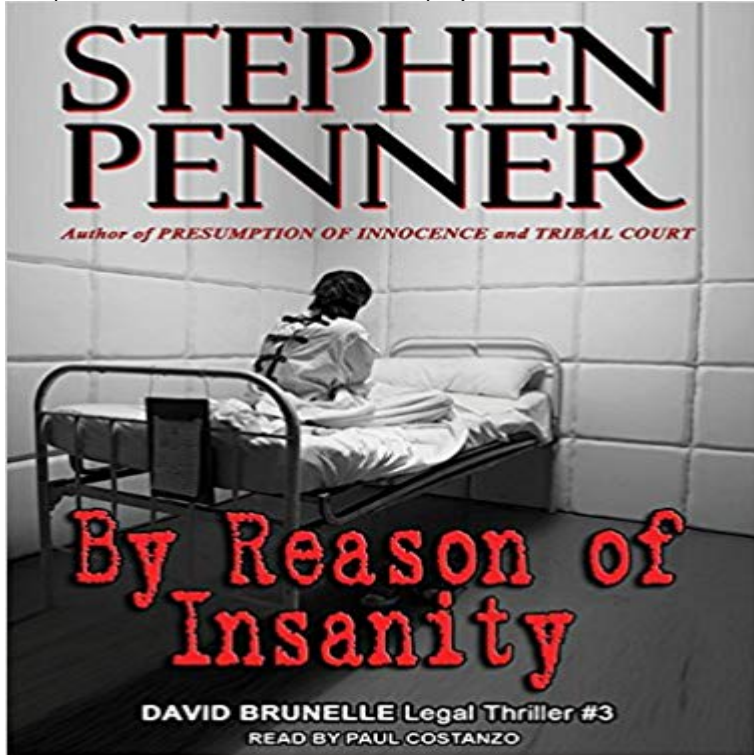


By Reason of Insanity (David Brunelle Legal Thriller)
