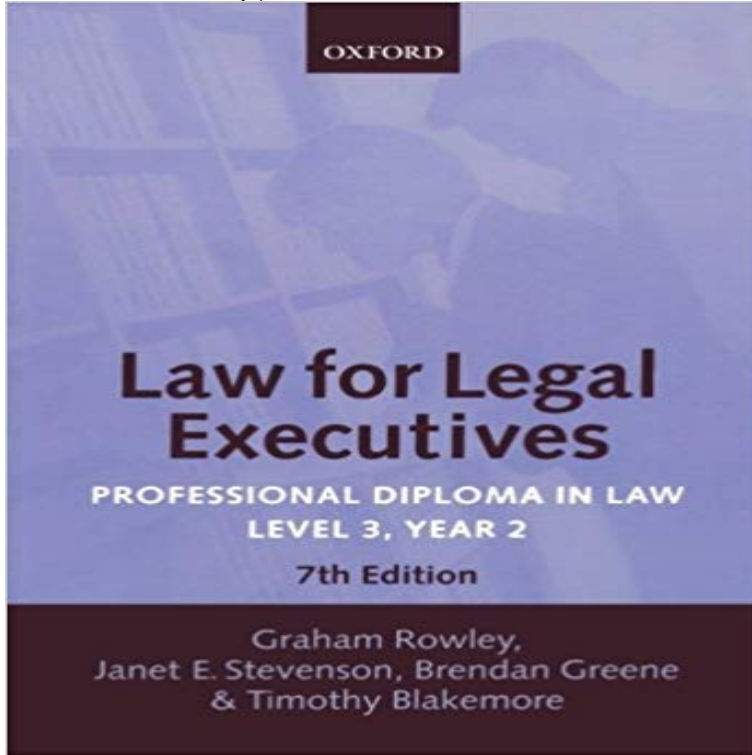


Law For Legal Executives: Level 3 Year 1
